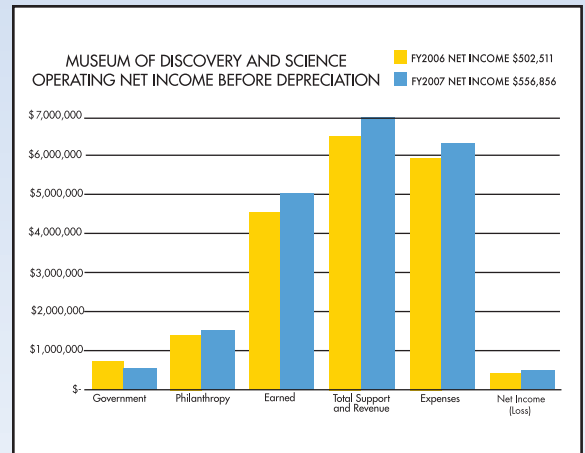

Fiscal Year 2007

- The Museum has an operating budget of nearly \$7 million in revenues and an endowment of over \$4 million in assets.
- Museum revenues increased by 8% overall, led by a 13% increase in earned income and a 7% increase in philanthropy.
- Attendance increased by 6% over prior year, to 406,000.
- Strong operating results continued, with pre-depreciation net income of \$556,856, which was 11% more than prior year.
- Earned revenues from admissions, program fees, sales and interest from endowment accounted for 72% of all Museum revenue; 21% was philanthropy and 7% was from government grants.
- School and group tour revenue increased by 9% over prior year.
- Earnings from program fees increased by 27%.
- The Museum endowment grew by 9.5%.
- In-kind support increased by 10% to a value of \$1.3 million.
- Of all operating expenses, 84% were devoted to exhibits, programs and films, while administration and finance accounted for 9% and fundraising for 7%.
